Buildings & Grounds Committee

Mr. Layfield reported that the Buildings & Grounds Committee met on November 5, 2012.

Mr. Layfield reported on the following items:

- The new heat system at the Carver Center has been functioning well and no reported outages. We are still working with Delaware Co- Op on the electric outage from last year.
- IRHS –The practice football field was discussed and a proposal reviewed. It was decided to go forward with the proposal from Paul's.
- SCHS Practice Field –The irrigation system is operating and the grass has come up thick and green. R+L will assist in the draining of the system and will be completing the work on the softball and baseball fields in December. Mr. Doug Hudson gave a report about the athletic fields and the results of his survey.
- Millsboro Middle Irrigation Update-The system has been tested by D.N.R.E.C and the engineers and we still are waiting for the Town and the attorneys to work out the insurance issues and the permit to operate the system instill pending.
- Georgetown Middle Auditorium Update- The project has been moving along nicely. The windows on the north and south have been installed the infill walls are built. Plaster repairs are being completed. Floors will be started on the week after thanksgiving. The painting is scheduled for completions on the week of 11/12/12. Seats are scheduled for delivery on the week of December 19th.
- Georgetown Middle Lights-Jeff Philips from Delmarva Power has reviewed the project is scheduled to remove the transformer and poles when they return from repairs due to hurricane Sandy.
- Storage needs for several locations-Proposals from 2 separate vendors are being reviewed. Principals have submitted their needs and wants; the committee will review and prioritize in the future. It was also discussed that storage buildings are not part of minor cap funds.
- Contingency Allocations and Prioritized Listing-Mr. Miller presented a list of items that have been identified as priority items and there was a brief discussion on those items.

- Ingram's Pond Tree Harvest Proposal-We will be moving forward with harvest proposal in the next month or so. The tree harvest price has gone up in recent months because of the wet conditions at other locations.
- East Millsboro Land Acquisition. Mr. Brittingham provided an update on the title issue and the progress being made. A different attorney is being used this will require new checks to be issued.
- Georgetown Middle Wireless Proposal-Patches is meeting with vendors and will be submitting a proposal for the committees review.

- Full Day Kindergarten was discussed. Mr. Hudson asked about the referendum questions being linked to implementation
- Mrs. Hudson reported that Advanced Placement, Honors and International Baccalaureate grade weighting would be a topic for the policy committee. She is drafting new language for review.
- Other Topics
 - O Mr. Hudson raised concern about all the press on Sussex Tech and Sussex Preparatory High School. He would like to get IRSD news out there, possibly buying TV time. A discussion took place about the need to get our academics in the press.
 - Dr. Bunting discussed the administrative professional learning community and professional development that is taking place surrounding Common Core Standards.
 - There was a discussion on Special Educators and qualifications. Mrs. Nina Lou Bunting is going to talk to the Governor's Task Force in regards to highly qualified rules in the area of Special Education.
