- Completed and posted the district's 2014-2015 Balanced Scorecard
- Attended open houses at the Kindergarten Center, East Millsboro, Sussex Central, Selbyville Middle, SDSA, Carver Academy, North Georgetown, and John M. Clayton
- Joined the heads of state department agencies to discuss a major statewide academic initiative
- Been selected to chair the DPAS II Advisory Committee and has also been selected to serve on the subcommittee that is charged with improving the teachers' current evaluation system
